#### Daemen College Refinancing Transaction Summary

Daemen College has submitted an application to the Town of Amherst Development Corporation for refinancing of certain outstanding obligations incurred by the College with respect to the construction and equipping of various facilities providing educational and housing services on its campus located at 4380 Main Street in the Town of Amherst, Erie County, New York.

Daemen College is financing all or a portion of the costs of the refinancing of the Town of Amherst Industrial Development Agency Multi-Mode Civic Facility Revenue Bonds Series 2006A issued on June 30, 2006 in the original aggregate principal amount of \$20,925,000, and Series 2006B also issued on June 30, 2006, in the original aggregate principal amount of \$17,075,000. The financing of all or a portion of the costs by the issuance of revenue bonds of in an aggregate principal amount sufficient to pay the cost of undertaking the Project, which also includes renovation and improvements to science facilities and other maintenance improvements, together with necessary incidental costs is presently estimated to be \$35,000,000 and is not to exceed \$37,000,000. The Project will receive a mortgage recording tax exemption as a result of the participation of the Town of Amherst Development Corporation.
